

His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam desired that an ASEAN Football Tournament to be organized with the aim of deepening awareness amongst the people of South East Asia, in particular its Youths, on ASEAN as an organizational entity. The outcome of this, is **The Hassanal Bolkiah Trophy** for ASEAN Youth Football Tournament for which the sixth series will be held from 23rd April 2018 to 5th May 2018.*

RULES AND REGULATIONS

SECTION 1: HASSANAL BOLKIAH TROPHY

1. INTRODUCTION

- 1.1 Hassanal Bolkiah Trophy for ASEAN Youth Football 2018 is organised by the Ministry of Culture Youth and Sports (MCYS) and National Football Association of Brunei Darussalam (NFABD) sanctioned by the Asian Football Confederation (AFC) in collaboration with the ASEAN Football Federation (AFF);
- 1.2 These Regulations set out the rights, duties, and responsibilities of the Hosting Country and the Participating Countries taking part in the Tournament;
- 1.3 The Tournament shall be called "The Hassanal Bolkiah Trophy (HBT) for ASEAN Youth Football Tournament 2018"
- 1.4 Tournament logo:



- 1.5 Participants will be from ASEAN member Countries which are members of ASEAN Football Federation (AFF) and affiliated to Asian Football Confederation (AFC) and FIFA; Brunei Darussalam, Malaysia, Singapore, Indonesia, Thailand, Myanmar, Laos, Vietnam, Cambodia, Philippines, Timor-Leste and any other Member Associations invited by the NFABD.
- 1.6 Each Participating Country shall send only one team representative.
- 1.7 The Tournament will be held from 23rd April 2018 until 5th May 2018 in Brunei Darussalam.

RULES AND REGULATIONS

SECTION 2: TECHNICAL OPERATIONS

2. MODE OF TOURNAMENT

- 2.1 The Participating Countries shall be divided into two (2) groups by means of a draw to be held on Wednesday, 21st March 2018. The Local Organising Committee shall decide on the membership of the groups and the match schedule in a public draw.
- 2.1.1 All Participating Countries will be officially invited to the draw. The travel expenses to the draw are to be borne by the respective Country. Each Country may send representatives from their respective Diplomatic Missions (High Commissions or Embassies) in Brunei Darussalam to witness or participate in the draw. In the absence of representatives from the Participating Country, National Football Association of Brunei Darussalam (NFABD) (and/or AFC/AFF) will act on behalf for the draw.
- 2.1.2 In the case of last minute withdrawal by one (1) Participating Country, a redraw shall be carried out to decide the new capacity of each Group if deemed necessary. Brunei Darussalam as the Host Country has the rights to carry out the redraw.
- 2.1.3 Member Associations after confirming their participation and for any reason withdrawing subsequently will be dealt by the NFABD Disciplinary and Ethics Committee with a maximum fine of USD10, 000 except in the case of 'force majeure'.

3. SEEDING

- 3.1 There shall be no seeding;
- 3.2 Brunei Darussalam, as the Host Country, shall have the privilege of choosing the Group they wish to be in during the draw. All the games for Brunei Darussalam shall be played at the Hassanal Bolkiah National Stadium, kickoff time at 2015hrs.

4. MATCH OFFICIALS

- 4.1 The Match Commissioners, Referee Assessors and Referees for the Hassanal Bolkiah Trophy (HBT) for ASEAN Youth Football Tournament 2018 will be appointed by the AFC/AFF.

5. TOURNAMENT SYSTEM

- 5.1 At the conclusion of each Match:
- 5.1.1 Three (3) points shall be awarded to the winner;
- 5.1.2 One (1) point shall be awarded to each Participating Country for a draw;
- 5.1.3 Zero (0) point shall be awarded for the loser
- 5.2 The Participating Country to advance to the Semifinals will be decided through the following:
- 5.2.1 Higher number of Points obtained in all Group Matches;
- 5.2.2 If two (2) or more Participating Countries are equal on points, the following criteria are applied to determine the ranking (in descending order):
- 5.2.2.1 Head-to-Head criteria
- 5.2.2.1.1 Higher number of Points obtained in the Group Matches played among the Participating Countries in question;
- 5.2.2.1.2 Superior Goal Difference from the Group Matches played among the Participating Countries in question;
- 5.2.2.1.3 Higher number of Goals Scored in the Group Matches played among the Participating Countries in question;

RULES AND REGULATIONS

5.2.2.2 Tiebreaker

5.2.2.2.1 If, after having applied the Head-to-Head criteria, two (2) or more Participating Countries still have equal ranking, the Head-to-Head criteria shall be reapplied exclusively to the Matches between the Participating Countries in question to determine their final rankings. If this procedure does not lead to a decision, the Group Results criteria shall apply:

5.2.2.3 Group Results criteria

5.2.2.3.1 Superior Goal Difference from all Group Matches played;

5.2.2.3.2 Higher number of Goals Scored from all Group Matches played;

5.2.2.3.3 Penalty Kicks if only the two (2) Participating Countries are both on the Field of Play;

5.2.2.3.4 The lower score calculated according to the number of yellow and red cards received in Group Matches (Annex 1); or

5.2.2.3.5 The drawing of lots.

5.3 During Semi-Finals, the Participating Countries shall play on a 'knock-out' basis as follows:

5.3.1 Semi Final 1 : Winner of Group A vs Runner-up of Group B

5.3.2 Semi Final 2 : Winner of Group B vs Runner-up of Group A

5.4 The winners of the Semi-Finals shall meet in the Final. The losers in the Semi-Finals shall be declared joint third (3rd) placed winners.

5.4.1 Final : Winner of Semi Final 1 vs Winner of Semi Final 2

6. MATCHES TO BE PLAYED IN ACCORDANCE WITH THE LAWS OF THE GAME

6.1 All Matches shall be played in accordance with the Laws of the Game laid down by the International Football Association Board (IFAB) and published by FIFA.

6.2 In case of any discrepancy in the interpretation of the Laws of the Game, the English version shall prevail and is authoritative.

6.3 Only three (3) substitutes listed on the 'Match Starting List' may take part in a Match. Any Participating Player who has been substituted may take no further part in that Match.

6.4 At any stage of a Match, if a Participating Country is only able to field fewer than seven (7) players, the Match shall be abandoned and Article 12.3 shall apply.

7. DURATION OF MATCHES

7.1 Each Match shall last ninety (90) minutes, comprising of two (2) periods of forty-five (45) minutes (normal playing time). Matches shall start at the time set out in the Match Schedule.

7.2 There shall be an interval of fifteen (15) minutes between the periods, commencing from the whistle ending the first period and ending upon the whistle starting the second period.

8. DELAY OF KICK-OFF

8.1 A Participating Country that causes a delay of any scheduled kickoff of a Match (as determined by the Official Countdown) may be sanctioned by the NFABD Disciplinary and Ethics Committee in its discretion.

9. EXTRA TIME IF DRAW

9.1 Extra Time is applied during the Semi-Finals and Final only in the case of the result after ninety (90) minutes is a draw. It shall consist of two (2) periods of fifteen (15) minutes, with an interval of five (5) minutes at the end of normal playing time, but no interval between periods of Extra Time.

RULES AND REGULATIONS

10. DETERMINING THE WINNER BY KICKS FROM THE PENALTY MARKS

- 10.1 If a Match is level after Extra Time, Kicks from the Penalty Mark shall be taken to determine the winner, in accordance with the procedures described in the FIFA Laws of the Game.
- 10.2 If Kicks, from the Penalty Mark cannot be completed because of weather conditions or for any Force Majeure reason, the result shall be decided by the drawing of lots by the Referee in the presence of the AFC Match Commissioner and the two (2) captains of the Participating Countries.
- 10.3 If through the fault of a Participating Country the kicks from the Penalty Mark cannot be completed, Article on 'Withdrawal After Commencement of the Tournament' in the Tournament Regulations shall apply.

11. CANCELLATION OF MATCHES

- 11.1 If a Match cannot commence for any reason, the following procedure shall be followed. Should the Match not be cancelled prior to Match day:
- 11.1.1 The Match must be delayed for a minimum of thirty (30) minutes. During this delay, the Referee may decide that the Match can commence prior to the completion of the delay;
- 11.1.2 Following the first delay, either:
- 11.1.2.1 An additional delay of thirty (30) minutes shall occur if in discretion of the Referee this second delay may allow the Match to commence; or
- 11.1.2.2 The Match declared cancelled by the Referee;
- 11.1.3 Following two (2) delays of thirty (30) minutes, the Referee must declare the Match cancelled.
- 11.2 Any Match which is cancelled, except in cases of Force Majeure recognised by the Local Organising Committee, may lead to the imposition of sanctions by the NFABD Disciplinary and Ethics Committee against the relevant party that has caused the cancellation in accordance with the AFC Disciplinary and Ethics Code.

12. ABANDONMENT OF MATCHES

- 12.1 If a Match has to be abandoned as a result of incidents (such as walkover, lack of orders, pitch invasions, bad weather, poor pitch condition, etc.), the Local Organising Committee will meet within two (2) hours of such incidents and determine the action to be taken.
- 12.2 Should the Local Organising Committee determine that an Abandoned Match should be rescheduled and completed, the following principles shall apply:
- 12.2.1 The Match shall recommence with the same score at the minute at which play was interrupted rather than being replayed in full;
- 12.2.2 The Match shall recommence with the same Participating Players on the Field of Play and same substitutes at the time it was initially abandoned;
- 12.2.3 No additional substitutes may be added to the Player Selection List or Match Starting List;
- 12.2.4 The Participating Teams may only make the number of substitutions to which they were still entitled when the Match was abandoned;
- 12.2.5 Any Participating Player sent off during the abandoned Match cannot be replaced;
- 12.2.6 Any sanction imposed before the Match was abandoned remain valid for the remainder of the rescheduled Match;
- 12.2.7 The kick-off time, date and Stadium of the re-scheduled Match shall be decided by the Local Organising Committee;
- 12.2.8 Should there be an abandonment of Match for whatever reason but not due to any misconduct or disciplinary reason, the score line at the time of stoppage (if after 75th minutes of game play) will be used for the award of points. The points awarded will be decided by the Local Organising Committee; and
- 12.2.9 Any other matters not set out above shall be decided by the Local Organising Committee in its sole discretion.
- 12.3 If a Match is stopped by the Referee before the end of normal playing time or during any Extra Time as a result of a Participating Country being able to only field fewer than seven (7) Participating Players, the Match shall be declared abandoned and the Participating Country who is able to field more than seven (7) Participating Players shall be declared the winner by the score 3-0, or the score at the time of abandonment, whichever is higher.

RULES AND REGULATIONS

- 12.4 Any Match which is abandoned, except in cases of Force Majeure recognised by the Local Organising Committee, may lead to the imposition of sanctions by the NFABD Disciplinary and Ethics Committee against the relevant party that has caused the abandonment in accordance with the AFC Disciplinary and Ethics Code.

13. WITHDRAWALS AND WALKOVERS

- 13.1 Withdraws from the Tournament after commenced or does not report for matches; or refuse to continue any of its matches at any stage; or leave the field prior to the completion of any of its matches shall be considered to have withdrawn from the Tournament after its commencement.
- 13.2 The Participating Country that withdraws from the Tournament after its commencement:
- 13.2.1 Shall have all its matches cancelled and considered null and void. For the avoidance of doubt, all points and goals in those matches shall not be taken into consideration when determining the final rankings in the Tournament pursuant to Articles 3 of AFC regulations;
 - 13.2.2 Shall be required to pay compensation for any and all damages or losses suffered by. The amount of compensation shall be determined by the NFABD Disciplinary and Ethics Committee;
 - 13.2.3 Be referred to the AFC Disciplinary and Ethics Committee which may impose further sanctions in its discretion.
- 13.3 All results related to withdrawals and walkover matches will be dealt by the Local Organising Committee. The decisions by the Local Organising Committee regarding these matters shall be final.

14. STADIUM

- 14.1 The main venue of the Tournament will be at Hassanal Bolkiah National Stadium (HBNS) and Track & Field, Hassanal Bolkiah National Sports Complex (TFHBNS).
- 14.2 Smoking is strictly prohibited within any stadium, and in particular, in the technical area, the vicinity of the Field of Play, or within Tournament areas which includes, without limitation, the team dressing room.
- 14.3 The use of drones at the Stadium and Official Training is strictly prohibited.

15. TEAM BENCH AND TECHNICAL AREA

- 15.1 Participating Officials and Participating Players on the team bench must wear their Accreditation Card at all times.
- 15.2 All individuals on the team bench must wear kit that contrasts with the kit of the Participating Players and Match Officials present on the Field of Play. This kit must comply with the AFC Equipment Regulations.
- 15.3 The use of any electronic communication equipment and/or systems between and/or amongst Participating Players and Participating Officials is not permitted.
- 15.4 Individuals serving a Match suspension, non-selected Participating Players, and Participating Officials part of the Team Official Delegation but not listed in 'Officials on the Team Bench List' are not permitted to enter the Field of Play and/or sit on the team bench. They may sit at the designated area in the stand for Team Official Delegations.

16. COOLING BREAK

- 16.1 Depending on the weather conditions, a cooling break may be implemented.
- 16.2 Cooling breaks of maximum three (3) minutes duration shall be implemented by the Referee at approximately thirty (30) minutes into the run-of-play in both halves (around the thirtieth (30th) minute and seventy-fifth (75th) minute respectively).

RULES AND REGULATIONS

17. OFFICIAL TRAINING AT THE STADIUM

- 17.1 Depending on the weather and condition of the Field of Play, each Participating Country is entitled to an official training of sixty (60) minutes duration in the Stadium in which they are due to play either one (1) or two (2) days prior to their first Match in the Stadium in the Tournament.
- 17.2 The Field of Play must be prepared to Match-condition for official training. If the field of Play is not in Match-condition, the AFC Match Commissioner may shorten or cancel the official training and direct the Participating Countries to inspect the Field of Play wearing training shoes only.
- 17.3 The Local Organising Committee will nominate and provide the Local General Coordinator and/or AFC Match Commissioner with the time and location of another official training at another designated Official Training Site. This shall be treated as the Official Training Venues for the Participating Countries for the duration of the Tournament.

18. FOOTBALLS

- 18.1 Footballs for Matches and Training sessions shall be selected and supplied by the Local Organising Committee. Only these Footballs can be used by Participating Countries at the Stadium and Training Fields during the official duration.

19. DRAW PRINCIPLES (If there is a tiebreaker to determine the team progress to the semi finals)

- 19.1 If a drawing of lots is required to decide the ranking in a group, the following principles shall apply:
 - 19.1.1 The names of Participating Countries in the Group concerned shall be placed into a pot;
 - 19.1.2 The first name drawn shall be the highest-ranked of the Participating Countries;
 - 19.1.3 If necessary and subject to the number of Participating Countries concerned, the procedure shall be repeated to determine the rankings of all Participating Countries concerned.

SECTION 3: TEAM OFFICIAL DELEGATION

20. ELIGIBILITY OF PLAYERS

- 20.1 Only players who are bona fide nationals of the country they represent are eligible to participate in the Tournament.
- 20.2 Players whom were born on or after 1st January 1997 shall be eligible to participate (Under 21). However, three(3) senior players are allowed to be registered and to play at every Matches;
- 20.3 The following documents shall be submitted to the Local Organising Committee for registration of Participating Players:
 - 20.3.1 A colour copy of a valid-issued passport, containing the full name, passport number, place of birth, date of birth, date of issue, date of expiry and nationality of the relevant Player. Group passports are not accepted;
 - 20.3.2 A colour copy of a national identification card (where applicable);
 - 20.3.3 One (1) passport-size colour photo (taken within three (3) months) prior to the submission of registration; and
 - 20.3.4 A copy of a birth certificate (when requested).
- 20.4 All documents shall be free from tampering, and any change or erasure must be endorsed or authenticated by the appropriate authority.
- 20.5 In cases of registration of players who have acquired a new nationality (cf. Article 7, FIFA Regulations Governing the Application of the Statutes), the documents set out in Annex 2 Tournament Rules must also be submitted.
- 20.6 In cases of registration of players who hold passport entitling them to represent more than one (1) Member Association (cf. Art. 6 FIFA Regulations Governing the Application of the Statutes), the documents set out in Annex 3 of the Tournament Rules must also be submitted.

RULES AND REGULATIONS

- 20.7 The Local Organising Committee may decide to not approve the registration of a player if any of the requirements set out in this Section 3 are not met.
- 20.8 A Participating Player shall be deemed ineligible, without limitation, if:
- 20.8.1 there is a violation of Article 20; or
 - 20.8.2 The Local Organising Committee determines that any document submitted during registration is false.

21. STAGES OF REGISTRATION OF PLAYERS

- 21.1 There shall be three (3) stages of player registration to be done through email using the address of hbt2018.secretariat@nfabd.org:
- 21.1.1 A list of not more than thirty (30) players shall be submitted to Local Organising Committee through respective Member Association, at least forty-five (45) days before the commencement of the Tournament. The list shall be authenticated by the respective Member Association and in accordance to Section 3 of the Tournament Regulations. Every Member Association is required to fill in the attached registration form to be submitted to the Local Organising Committee and shall contain the following information:
 - 21.1.1.1 A colour copy of a valid-issued passport, containing the full name, passport number, place of birth, date of birth, date of issue, date of expiry and nationality of the relevant individual. Group passports are not accepted;
 - 21.1.1.2 Full name (as in passport) of each player and to be printed in block capitals;
 - 21.1.1.3 Three (3) colour photographs (passport size) of each player taken in the current year (Please write the name and passport number at the back of the photographs);
 - 21.1.1.4 Date and place of birth of each player;
 - 21.1.1.5 Name on jersey;
 - 21.1.1.6 Playing position.
 - 21.1.2 From the list of thirty (30) players submitted, each Participating Country may register twenty-three (23) players one (1) month before the commencement of the Tournament. However, only the first eighteen (18) players will have full board and lodging together with local transport be borne by the Local Organising Committee. The Additional Participating Players will be under the cost of the respective Participating Country. The final registration of the twenty-three (23) Players shall also include three (3) Goalkeepers together with the jersey number from 1 to 23, and only these players shall be eligible to play in the Tournament;
 - 21.1.3 Only eighteen (18) Players shall be listed to be eligible to play in the 'Match Starting List' during Match Day.
- 21.2 All Participating Players will be issued with Accreditation Cards authorised by the Local Organising Committee and produced by MCYS. Should a card be misplaced, the Participating Country shall be required to pay USD100.00 as a replacement production fee.
- 21.3 A player listed on the final list of twenty-three (23) players may only be replaced in the event of serious injury up to one (1) day before the kick-off of his team's first Match after the Local Organising Committee have received a detailed medical assessment and only after the acceptance and confirmation by the NFABD appointed Medical doctor. The NFABD appointed Medical doctor shall issue a letter of consent stating the injury is sufficiently serious to prevent the player from taking part in the Tournament. Upon approval, the participating Member Association shall immediately nominate a replacement from the preliminary list of thirty (30) players and inform the Local Organising Committee accordingly. The Local Organising Committee shall not be responsible for any costs incurred due to a player replacement including airfares.
- 21.4 Should the Participating Country decided to bring extra players; they shall be borne by the Member Association of the Respective Country.

RULES AND REGULATIONS

22. REGISTRATION OF OFFICIALS

- 22.1 Each Participating Country can register up to eight (8) officials in the registration, but only five (5) officials will be considered as the Official Team Delegation whose full board and lodging together with local transport will be borne by Local Organising Committee. The Additional officials will be under the cost of the respective Participating Country;
- 22.2 The following documents shall be submitted to the Local Organising Committee for registration of Participating Officials:
- 22.2.1 A colour copy of a valid-issued passport, containing the full name, passport number, place of birth, date of birth, date of issue, date of expiry and nationality of the relevant individual. Group passports are not accepted;
 - 22.2.2 A colour copy of a national identification card (where applicable);
 - 22.2.3 One (1) passport-size colour photo (taken within three (3) months) prior to the submission of the registration;
 - 22.2.4 Evidence of their qualification based upon their function:
 - 22.2.4.1 Head coach; Assistant coach; Fitness coach; Goalkeeper coach; and
 - 22.2.4.2 Team doctor: relevant medical qualification.
 - 22.2.5 The Local Organising Committee reserves the right to request additional documents in all cases.
- 22.3 Participating Countries may register up to eight (8) Participating Officials to be listed on the Officials on the Bench Form. The following two (2) Participating Officials must be registered on the Officials on the Bench Form and signed by the AFC Match Commissioner;
- 22.3.1 Head coach, and
 - 22.3.2 Team Manager
- 22.4 Each Participating Country may register any other six (6) Participating Officials for any other positions, including without limitation:
- 22.4.1 Assistant Coach;
 - 22.4.2 Goalkeeper Coach;
 - 22.4.3 Fitness Coach / Trainer;
 - 22.4.4 Media Officer;
 - 22.4.5 Doctor;
 - 22.4.6 Physiotherapist;
 - 22.4.7 Interpreter;
 - 22.4.8 Security Officer;
 - 22.4.9 Video Analyst;
 - 22.4.10 Technical Director;
 - 22.4.11 Equipment Manager / Kitman.
- 22.5 The final list of Participating Officials shall be registered at least one (1) month before commencement of Tournament and to be included together with the registration of players as stated in Article 21 and must contain the following information:
- 22.5.1.1 Full name as in passport of each Participating Officials and to be printed in block capitals
 - 22.5.1.2 One (1) colour photographs (passport size) of each Participating Officials taken in the within three (3) months (Please write the name and passport number at the back of the photographs);
 - 22.5.1.3 The position of each Participating Officials;
 - 22.5.1.4 Each Participating Officials' Passport number.
- 22.6 All Participating Officials will be issued with Accreditation Cards authorised by the Local Organising Committee and produced by MCYS.
- 22.7 Once the registration of Participating Officials has been received by the Local Organising Committee, Participating Countries may replace any of the listed Participating Officials at any stage of the Tournament not later than seven (7) days before the Opening Ceremony of the Tournament, subject to the provision of the relevant documents in Article 22.2. Only when a replacement Participating Official has received his Accreditation Card will he be eligible to participate in the Tournament. The cost of replacement for the Participating Official will be borne by the respective Participating Country.

RULES AND REGULATIONS

23. SIZE OF DELEGATION AT MATCHES (OFFICIAL START LIST)

- 23.1 Each Participating Country shall register a Team Official Delegation comprising of maximum eighteen (18) Participating Players and maximum of five (5) Participating Officials for each Match (Official Start List);
- 23.2 The Team Official Delegation shall be granted full access to all official areas, including the Field of Play and other necessary Controlled Accessed Areas, as determined by the Local Organising Committee;
- 23.3 The Team Media Officer and/or Team Manager shall be responsible for coordinating all Participating Country and media-related matters with the Local Organising Committee. They shall participate in all Official Functions related to the Matches, including without limitation the match coordination meeting and all press conferences;
- 23.4 Participating Country shall ensure that no unauthorized persons are permitted entry into the team dressing room, Field of Play, or any other Controlled Access Area requiring Accreditation Card.
- 23.5 Failure to submit the duly completed Team's Registrations (Players and Officials) by the deadline will be subjected to being sanctions by the NFABD Disciplinary and Ethics Committee with a fine of USD10,000.00.

SECTION 4: LOGISTICAL ARRANGEMENTS

24. ARRIVAL AND DEPARTURES

- 24.1 Each Participating Countries shall arrive at Brunei Darussalam two (2) days before the date of the first Match of the Tournament or by the official arrival date determined by the Local Organising Committee;
- 24.2 Each Participating Countries shall depart Brunei Darussalam one (1) day after their Matches has been completed;
- 24.3 Participating Countries shall bear all costs as a result of arriving earlier or departing late from Brunei Darussalam;
- 24.4 Participating Country shall not play any non-official matches when in Brunei Darussalam.

25. LOCAL TRANSPORTATION

- 25.1 Brunei Darussalam shall provide dedicated vehicles for all Delegations for the duration of stay.
- 25.2 The following vehicles shall be provided to each Participating Countries for the duration of stay:
 - 25.2.1 One (1) dedicated sedan or Multi-Purpose Vehicle (MPV);
 - 25.2.2 One (1) dedicated bus with minimum forty (40) seats.

26. VISAS

- 26.1 Each Participating Countries must apply for all necessary visas for their Team Official Delegation no later than thirty (30) days prior to commencement of the Tournament. Visa application costs shall be covered by Brunei Darussalam.
- 26.2 Any Participating Country unable to fulfill the Tournament Fixture as a result of failing to secure visas shall be referred to the NFABD Disciplinary and Ethics Committee.

27. ACCOMMODATION FOR PARTICIPATING COUNTRIES

- 27.1 Brunei Darussalam shall cover all the cost of accommodation for the eighteen (18) Participating Players and five (5) Participating Officials for every Participating Countries only. Any extra charges incurred will be at the expense of Participating Countries;
- 27.2 Each Participating Countries shall pay for incidental expenses incurred by its Team Officials Delegations during the course of their stay in Brunei Darussalam, all costs relating to the extension of their stay in Brunei Darussalam, and all costs incurred by additional members of the delegation;
- 27.3 Only official hotels approved by the Local Organising Committee shall be used as Accommodation;
- 27.4 Suitable meals, three (3) times a day, and any additional light food for Participating Countries scheduled to play in the evening will be provided by the Local Organising Committee;
- 27.5 Should the Participating Country decide to be accommodated in a different hotel than that proposed by the Local Organising Committee, it shall be responsible for its own costs. It shall ensure that the Local Organising Committee is notified at least one (1) week prior to their first Match.

RULES AND REGULATIONS

SECTION 5: MEDIA

28. MEDIA RIGHTS

- 28.1 NFABD owns and is entitled to use and exploit all Media Rights relating to the Tournament.
- 28.2 Participating Countries, Participating Players and Participating Officials may engage their respective recording or media person(s) to record any part of a Match or official training only with the prior written approval of the Local Organising Committee. The use of any such footage shall only extend for non-commercial purposes.
- 28.3 The Local Organising Committee reserves the right to withhold or revoke any Media Rights granted at any time prior to or during the Tournament.

29. PRE-MATCH PROMOTIONAL MATERIAL

- 29.1 Prior to the commencement of each Match, the Participating Countries shall, upon request by the Local Organising Committee, provide the Local Organising Committee, free of charge, with photographs and audio-visual materials regarding the Participating Country, Participating Players and Participating Officials and any further information (including without limitation, statistics and historical information) as requested.
- 29.2 All Participating Countries hereby grant the Local Organising Committee the right to use and where applicable, authorise the Local Organising Committee to use the aforesaid provided materials for promotional and/or editorial purposes relating to the Tournament
- 29.3 All materials shall be provided to the Local Organising Committee in a timely manner, and in the format as prescribed by the Local Organising Committee.

30. TEAM MEDIA OFFICER

- 30.1 Each Participating Country shall appoint a dedicated English-speaking media officer to coordinate all media arrangements between the Local Organising Committee and where applicable, the Participating Countries, Participating Officials, the Host Broadcaster and the Media, including without limitation all press conferences and interviews, and to cooperate on all related matters with the at the Tournament venue.
- 30.2 The Participating Countries shall be responsible to ensure that their appointed media officer briefs all Participating Players and/or Participating Officials in respect to their respective media obligations as required by the Local Organising Committee.
- 30.3 The Participating Countries and their appointed media officer shall be responsible in ensuring the provision of interpretation services where any of their Participating Players or Participating Officials conducts media sessions in languages other than English. For the avoidance of doubt, the interpretation services provided shall be for translation of dialogues from all other languages to the English language.
- 30.4 Where applicable, the Participating Country and their appointed media officer shall be responsible for the distribution and translation of the relevant media guidelines as set out in Annex 4 (Photographer Guidelines) of the Tournament Rules.

RULES AND REGULATIONS

31. PRESS CONFERENCES AND INTERVIEWS

- 31.1 NFABD reserves all rights in respect to the coordination of all public relations and communication activities relating to the Tournament including without limitation the coordination of all press conferences, interviews and release of press statements and the selection of designated media areas for the conducting of all press conference and interview sessions.
- 31.2 Participating Countries, Participating Players and Participating Officials shall participate and provide full support to the Local Organising Committee in relation to any public relations and communication activities organised by the Local Organising Committee.
- 31.3 The Participating Countries and their appointed media officer shall be responsible to ensure the provision of interpretation services where any of their Participating Players or Participating Officials conducts press conferences and interviews in languages other than English.
- 31.4 For the avoidance of doubt, the interpretation services provided shall be for translation of dialogues from all other languages to the English language.
- 31.5 The Participating Countries through its appointed media officer shall assist the Local Organising Committee and where applicable the Local Organising Committee Commercial Rights Partner with the coordination of all press conference and/or interview sessions by ensuring that the members of their Team Official Delegation selected to conduct any such activities are available and brought to scheduled sessions in a timely manner.
- 31.6 The Participating Countries shall ensure that the selected members of their Team Official Delegation conducting any press conference or interview sessions refrain from making any statements or references which will or is likely to damage or bring into disrepute the good name, image and reputation of country, the Tournament or sport of association football.
- 31.7 The Participating Countries shall ensure, during any press conference or interview session, that:
- 31.7.1 the products or other identifiers of their affiliated Member Association, the Participating Countries, Participating Players, Participating Officials, or their commercial partners or any associated third parties do not appear or are not used in any manner;
 - 31.7.2 Their Participating Players and Participating Officials do not make reference to any third-party products or entities.
- 31.8 In the event the Head Coach is suspended for the Match, the Participating Country shall request the individual replacing the Head Coach on the team bench to attend any scheduled press conferences or interview sessions.
- 31.9 Should the Head Coach or Team Manager be unavailable for interviews, the Media Officer from Participating Countries should delegate the Assistant Coach or Team Captain to attend the interview.
- 31.10 If requested by the Local Organising Committee, each Participating Country shall make their Head Coach and one (1) Participating Player available for an interview of up to ten (10) minutes, to be recorded by the Host Broadcaster or any other Official Licensee.
- 31.11 Where the Local Organising Committee organises additional media activities, such as the Mixed Zone, such activities may supplement but not replace the obligatory press conferences or interview sessions. Notwithstanding the above, the Participating Countries shall ensure that their Participating Players and Participating Officials participate in such activities.

RULES AND REGULATIONS

- 31.12 Should the Participating Country decide not to attend any of their pre-match, post-match interviews or other related media activities, the Participating Country can be forwarded to the NFABD Disciplinary and Ethics Committee for further actions.

32. MIXED ZONE

- 32.1 NFABD shall ensure that a mixed zone containing a sectioned-off area reserved for the Broadcast Licensees is set up and organized for the media after the Match, and that the Mixed Zone is conducive and safe for Participating Players and officials to pass through from the dressing rooms to the team transport area.
- 32.2 Participating Member Associations, Participating Countries, Participating Players and its officials acknowledge that it is mandatory to pass through the Mixed Zone.
- 32.3 Speaking to the media in the mixed zone is not compulsory. However, it is strongly recommended that Players and officials give brief interviews to the media.

33. OFFICIAL TRAINING

- 33.1 All official training is open to the Media.
- 33.2 Should a Participating Country wish to close its official training to the Media, it shall, as a minimum, open the session for the first fifteen (15) minutes of the training session.

SECTION 6: EQUIPMENT

34. GENERAL REQUIREMENTS

- 34.1 Each Participating Countries must comply with the AFC Equipment Regulations.
- 34.2 The AFC Equipment Regulations are operational from the arrival of each Countries Official Delegation at a Controlled Access Area until the departure of each Team Official Delegation from such areas.

35. KIT APPROVAL

- 35.1 All Participating Countries shall declare their first and second kit colours during the Matches Coordination Meeting, and are obliged to use these colours of their Matches.

36. ALLOCATION OF KIT COLOUR

- 36.1 The AFC Official Delegation shall decide on the kit colour (jersey, shorts, and socks) to be worn for each Match on the basis of the equipment information submitted by each Participating Countries during the Match Coordination Meeting.
- 36.1.1 Team A shall be given priority to wear 'official' colours;
- 36.1.2 Team B shall wear 'official' colours unless they clash with the 'official' colours of Team A;
- 36.1.3 Team B shall wear 'reserve' colours if its 'official' colours clash with the 'official' colours of Team A;
- 36.1.4 Team B shall wear a combination of 'official' and 'reserve' colours if it is necessary to avoid a clash with the 'official' colours of Team A; and
- 36.1.5 Team A and Team B shall wear a combination of 'official' and 'reserve' colours if both the 'official' and 'reserve' colours of Team B clash with the 'official' colours of Team A.

RULES AND REGULATIONS

SECTION 7: COMMERCIALS

37. COMMERCIAL RIGHTS

- 37.1 The Local Organising Committee owns and is entitled to use and exploit all Commercial Rights relating to the tournament, whether created in the past, present or future and reserves all rights in respect to the use and/or license of such rights worldwide.
- 37.2 Participating Countries shall provide the necessary assistance and support to the Local Organising Committee and ensure that members of its Team Official Delegation and associated third parties observe all instructions of the Local Organising Committee in relation to the protection and enforcement of the Commercial Rights or any commercial programme established by the Local Organising Committee for the Tournament.
- 37.3 Member Associations, Participating Countries, Participating Players and Participating Officials shall not oppose and shall use reasonable efforts to ensure that none of its affiliates oppose any trademark or copyright applications filed in respect to the Local Organising Committee or the Tournament and may not in any way challenge or apply for any copyright, trade mark, patent or domain name registrations which would adversely affect the Local Organising Committee's proprietary interest in the Tournament.
- 37.4 Member Associations, Participating Countries, Participating Players and Participating Officials shall promptly notify the Local Organising Committee of any infringement or suspected infringement of any intellectual property rights relating to the Tournament upon becoming aware of any such matter.

38. IMAGE RIGHTS

- 38.1 The Local Organising Committee is entitled to use and exploit all Image Rights relating to the Tournament and reserves all rights in respect to the use and/or license of such rights throughout the Territory for any purposes, commercial or otherwise, free from any royalty or compensation, in relation to the Tournament and grant of rights in relation thereto.
- 38.2 Member Associations, Participating Countries, Participating Players and Participating Officials acknowledge that their participation and attendance in the Tournament shall constitute agreement to the use and/or recording of their image, voice or likeness without notice or compensation, and shall indemnify, release, defend and hold harmless the Local Organising Committee and Official Licensees from any and all claims relating to the use of their images and likeness in relation to the Tournament and/or grant of rights relating to the Tournament.
- 38.3 Member Associations, Participating Countries, Participating Players and Participating Officials shall ensure that no individual, company or commercial entity used and/or exploits the Image Rights in any way which may likely draw or infer an association to the Local Organising Committee, the Tournament or Official Licensees, and shall inform the Local Organising Committee immediately of any unauthorised use or infringement of the Image Rights.

39. PUBLIC EXHIBITION RIGHTS

- 39.1 The Local Organising Committee is entitled to exploit all Public Exhibition Rights relating to the Tournament and reserves all rights in respect to the use and/or license of such rights.
- 39.2 Member Associations, Participating Countries, Participating Players, Participating Officials and any third parties associated to the Tournament shall not organise any form of public exhibition of the Tournament, at any time, whether prior to, during or after the Tournament period without the prior written approval of the Local Organising Committee.

RULES AND REGULATIONS

- 39.3 Any intention or proposed intention to hold or organise any form of public exhibition and/or use or exploit any Public Exhibition Rights relating to the Tournament shall be subject to the prior written approval of the Local Organising Committee and in accordance to the directions and instructions as issued by the Local Organising Committee.

40. OFFICIAL FUNCTIONS

- 40.1 The Local Organising Committee is entitled to exploit all rights relating to the Official Functions and events relating to the Tournament and reserves all rights in respect to the organising and/or staging of such functions or events throughout the Territory.
- 40.2 Member Associations, Participating Countries, Participating Players, Participating Officials and any third parties associated to the Tournament shall not organise any Official Functions or events relating to the Tournament without the prior written approval of the Local Organising Committee. Any party that wishes to organise and/or stage any Official Function shall provide the Local Organising Committee with a detailed plan setting out among others the date, time and venue of the proposed function or event and shall follow and comply with any directions or instructions issued by the Local Organising Committee regarding the overall organising and/or staging of the Official Function.
- 40.3 Any events or functions proposed to be organised and/or staged shall be on a noncommercial basis with no sales of tickets or payment in cash or kind from any third party or company and/or no association to the Local Organising Committee.

SECTION 8: MEDICAL & ANTI DOPING

41. Doping is forbidden. The AFC Anti-Doping Regulations, the AFC Disciplinary and Ethics Code, and all relevant AFC directives in relation to anti-doping are applicable to the Tournament;
42. Doping Control Tests shall be done in accordance with the procedures laid down in the Doping Regulations of FIFA;
43. Each Participating Country shall ensure that each Participating Player undergoes a pre-competition medical assessment (PCMA) at least thirty (30) days prior to their first Match of the Tournament;
44. Any Participating Player for whom the required documents are not provided is not eligible to be registered for the Tournament;

SECTION 9: DISCIPLINARY

45. Disciplinary Measures

- 45.1 All disciplinary measures in relation to the Tournament shall be undertaken in accordance with the current AFC Statutes, AFC Disciplinary and Ethics Code, and any relevant AFC circular;
- 45.2 Only Participating Players and Participating Officials may serve match suspensions in the Tournament.
- 45.3 All Participating Players agree to:
- 45.3.1 Respect the spirit of fair play, non-violence, and the authority of the Match Officials;
 - 45.3.2 Behave accordingly;
 - 45.3.3 Refrain from doping.

46. GOOD CONDUCT

- 46.1 Participating Countries are liable for the improper conduct of:

RULES AND REGULATIONS

- 46.1.1 Any member of its Team Official Delegation; and/or
- 46.1.2 Any person carrying out duties on their behalf throughout the Tournament;
- 46.2 For any violation of Article 48.1, the NFABD Disciplinary and Ethics Committee may issue any sanction listed in the AFC Disciplinary and Ethics Code.
- 46.3 Any sanction issued administratively comes into force immediately upon notification in accordance with the AFC Disciplinary and Ethics Code.

47. INDISCIPLINE OR VIOLENT CONDUCT

- 47.1 Any individual reported for any act of indiscipline or violent conduct at the Stadium (including without limitation within the team dressing room or on the Field of Play), Official Training Site, Accommodation, or any other location within Brunei Darussalam shall be referred to the NFABD Disciplinary and Ethics Committee.

48. PROTEST

- 48.1 A protest is an objection of any kind to any matter that has a direct effect on Matches and any matters related to a breach of these Regulations or the AFC Disciplinary and Ethics Code.
- 48.2 Protests, to be considered valid, shall be:
 - 48.2.1 Submitted in writing on the Protest Form to the AFC Match Commissioner within two (2) hours of the end on the Match in question; and
 - 48.2.2 Followed up with a full written report, including a copy of the original protest, sent to the the Match Commissioner within forty-eight (48) hours after the end of the Match.
- 48.3 No protest shall be lodged relating to the Referee's decisions regarding facts connected with play. Such decisions are final and binding and not appealable;
- 48.4 Should NFABD Disciplinary and Ethics Committee determine that a protest is unfounded or irresponsible, it may impose a fine;
- 48.5 If any of the formal conditions of a protest as set out in these Regulations are not met, such protest shall be disregarded. Following the completion of the final Match of the Tournament, all protests shall be disregarded.

SECTION 10: ADMINISTRATION

49. FAIR PLAY AWARD

- 49.1 Fair Play should be actively promoted throughout the Tournament;
- 49.2 The Organising Committee will present a Fair Play Trophy to the best Participating Country who will be picked by the NFABD Disciplinary and Ethics Committee based on marks allocated in the FIFA Guidelines for choosing the Fair Play Winner as per attached in Annex 5 of the Tournament Rules.

50. TROPHY, MEDAL & OTHER PRIZES

- 50.1 The following will be given to respective Winners
- 50.1.1 Champion
 - 50.1.1.1 The Challenge Trophy
 - 50.1.1.2 Thirty-one (31) Gold medal to each Participating Officials and Players
 - 50.1.1.3 BND20,000.00
 - 50.1.2 Runner-Up
 - 50.1.2.1 Thirty-one (31) Silver medal to each Participating Officials and Players
 - 50.1.2.2 BND10,000.00
 - 50.1.3 Joint Third Place
 - 50.1.3.1 Thirty-one (31) Bronze medal to each Participating Officials and Players
 - 50.1.3.2 BND5,000.00
- 50.2 Fair Play Award is awarded to the Participating Country that has collected the most Fair Play points in the Tournament;
- 50.3 The Top Goal Scorer to the Participating Player who has scored the highest number of goals in the Tournament.
- 50.4 Appreciation Award for Match Officials of the Final Match.

51. DECISIONS

- 51.1 All decisions made in accordance with these Regulations, except where expressly identified otherwise, and are final and binding and not appealable in accordance with the NFABD Statutes.

52. AMENDMENTS

- 52.1 The NFABD reserves the right to make amendments to any part of these Regulations for any reason whatever. Such amendments shall be duly communicated in due course.

53. FORCE MAJEURE

- 53.1 The Local Organising Committee and AFC are the only body capable of declaring a Force Majeure event.

54. MATTERS NOT PROVIDED FOR

- 54.1 If there is any disagreement in the interpretation of the Tournament Regulations, the Local Organising Committee will be the final authority on all Technical Regulations. Such decisions are final and binding and not appealable.

Annex 1: Determining the ranking in a group using Fair Play criteria

1. Each Participating Team shall be awarded points for receiving red and yellow cards as indicated below:

- 1.1 per yellow card: one (1) point;
- 1.2 per red card (as a consequence of two yellow cards): three (3) points;
- 1.3 per red card (direct): three (3) points; and,
- 1.4 per yellow card followed by a red card (direct): four (4) points.


2. The Participating Team receiving the least number of points shall be ranked highest. The remaining Participating Teams shall be ranked in descending order.



Annex 4: Photographers Operations

1. Failure to adhere to this Annex may result in the ejection from a Stadium and refusal of accreditation for future Competitions;
2. All photographers requiring access to the competition must contact the Local Organising Committee and complete the necessary application procedures to clear their request;
3. All photographers requiring pitch-side access must wear a Media Identity Bib. Bibs are available from the Local Organising Committee at the entrance to a Stadium in exchange for a journalist ID card;
4. Team lists will be made available latest forty five (45) minutes before kick-off in the media centre;
5. Access to the Field of Play is not permitted at any time, including before and after the Match;
6. Before the start of each Match, photographers may shoot the line-ups of the Participating Teams from the touchline, but must not enter the Field of Play;
7. Once the Match starts, photographers must stay behind the advertising boards behind the goals and are not permitted to change sides until half-time, the end of normal playing time, or the start of extra time. When changing ends, photographers should pass along the near side of the Field of Play, not behind the advertising boards. Under no circumstances will photographers be allowed to shoot from either touchline during the Match;
8. The coaches of the Participating Teams shall attend a press conference that will commence immediately after the Match. At the press conference, all photographers must stand at the rear of the room and allow journalists to be seated towards the front;
9. The official Local Media Officer photographer may work from any position, including touchlines, but should not move during the Match. The instructions provided by the Commercial Rights Partner present at a Stadium shall be followed;
10. Photographers are required to obtain the prior authorisation of the Local Media Officer before setting up any remote camera in designated areas.

Annex 5: Calculation for Fair Play Award

1. Red and yellow cards

Maximum score = 10

Yellow card = -1 point

Red card = -3 points

No minimum score

If a player who is on a yellow card (-1 point) commits another yellow card offence, only the red card will count (-3 points). But if a player who has already been cautioned then commits a red card offence, both cards will count (so the player will receive -4 points). This is the only section in which it is possible to receive a score below zero.

2. Positive play

Maximum score = 10

Minimum score = 1

This is designed to encourage attractive play that will increase the enjoyment of spectators and the following areas are taken into consideration:

POSITIVE

- Using attacking tactics, not defensive
- Speeding up the game
- Efforts to gain time (e.g. bringing the ball back into play quickly even if the team is in a winning position)
- Continuing to push for goals when in a winning position

NEGATIVE

- Slowing down the game
- Time wasting
- Tactics based on foul play
- Play-acting (simulation)

3. Respect towards opponents

Maximum score = 5

Minimum score = 1

Players should respect the Laws of the Game and abide by the spirit of Fair Play. The Fair Play delegate's assessment will not double count items already covered in the 'Red and Yellow cards' category, but the seriousness of the offences punished by cards may be considered. This category will also include offences overlooked by the referee.

Any single major incident between players may have a significant bearing on the final score.

Blameless behaviour without any particularly positive attitude or gestures is likely to receive a score of 4 rather than 5.

4. Respect towards the referee

Maximum score = 5

Minimum score = 1

Players are expected to respect the officials - including assistants - at all times.


The Fair Play delegate's assessment will not double count items already covered in the 'Red and Yellow cards' but the seriousness of the offences punished by cards may be considered. Any single major incident may have a significant bearing on the score.

A positive attitude, including the acceptance of doubtful decisions without protest, will be rewarded with high marks. Normal behaviour without any particular positive attitudes or gestures towards match officials is likely to receive a score of 4 rather than 5.

5. Behaviour of the team officials

Maximum score = 5

Minimum score = 1



RULES AND REGULATIONS

Team officials, including coaches, are expected to develop the sporting, technical and tactical level of their team – and instruct players to behave in accordance with the Fair Play principles.

Positive and negative aspects of the team officials' conduct will be assessed – such as whether they calm down or provoke angry players or fans and how they accept the decisions of the referee. Co-operation with the media will also be taken into account.

Any single major incident may have a significant bearing on the final mark, as will breaches of the regulations governing the dugout and technical area.

Blameless behaviour without any particularly positive attitudes or gestures is likely to receive a score of 4 rather than 5.

For categories 1-5, the overall assessment of a team is obtained by adding up the points given for the individual categories, dividing this sum by the maximum points score (40) and multiplying it by 10.

In addition, there is one further category assessed by the NFABD Disciplinary and Ethics Committee.

6. Behaviour of the public

Maximum score = 5


Minimum score = 0

All teams begin with a score of 5 points. A maximum of a further 5 points can be added for:

- Verbal support in acceptable form
- Covert recognition of outstanding play by the opponents

A maximum of 5 points can be deducted for:

- Persistent foul and abusive language
- Persistent abuse of the officials' decisions
- Aggressive and threatening conduct towards opposing fans




